Box 761 Keller, Texas, 76244**, along with a CD, cassette, or link to online recording of at least two songs, and photograph (non-professional photos accepted) by **May 15, 2009**.

**Additional Rules and Conditions:** Completing this application is no guarantee of selection or performance. There is a \$25 registration fee. There is no guarantee of how many bands/performers will be selected to participate. Selection of bands will be made at the sole discretion of the Greater Keller Chamber of Commerce. Bands selected to perform will be notified by May 20, 2009. As a condition of performance, each person performing shall complete and execute a Release and Waiver of All Claims and an authorization to use name and likeness provided by the Chamber (if such person is under the age of 18, then a parent or legal guardian must sign said release and authorization). All CDs and photographs become the property of the Chamber and will not be returned, regardless of selection to perform.

Each band will have no more than 10 minutes to set up, no exceptions. Each band will be allowed to perform 2 songs, time permitting. The Chamber reserves the right to remove a band from the stage for any reason it deems necessary, including if a band exceeds its allotted time for set up or performance. If set-up exceeds allotted time, the bands will not be allowed additional time to perform.

Band performances will be evaluated by judges selected by the Chamber. Judges, in their sole discretion, shall choose the winning band. The judges' decision is final. The undersigned agrees to indemnify, release and hold harmless the Chamber, venue owners, any sponsors, and each such person or entities' employees, officers, directors, or other agents, for and from any damages, injuries, claims, or expenses of any nature suffered by any person participating in the contest or that in any way arise from any such participation or application.
